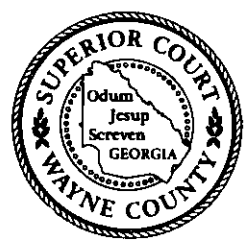

REPORTING: Please call (912) 715-2011 or (912) 424-1270 the weekend before you are scheduled to report for further instructions. If you have questions regarding this summons, contact the office of the Clerk of Superior Court (912) 427-5930.

SECURITY CHECKPOINT: All persons entering the Courthouse must pass through security and may be subject to a personal search. Please do not bring purses, pagers or cell phones into the Courthouse.

WHO MUST SERVE: The right to trial is a fundamental American right guaranteed by our state and federal constitutions. Jury service is both a privilege and a duty for qualified citizens of this country. Jurors are selected by a random process from various source lists.

JUROR REIMBURSEMENT: You will be reimbursed \$25.00 per day for expenses incurred while serving as a juror.

CERTIFICATES OF SERVICE: As a courtesy, the Clerk of Superior Court and State Court will provide a Certificate of Service, which you may present to your employer, showing that you served as a juror on specified dates. You may want to keep a copy of the certificate for your records.

REQUEST FOR DEFERRAL/EXCUSAL FROM JURY DUTY: If you would like to request a deferral/excusal from jury duty, please complete the attached Jury Affidavit along with any documentation to support the excusal or deferral and mail to: Frances B. Yeargan, Clerk of Superior Court, P.O. Box 920, Jesup, GA 31598.

DRESS CODE: Proper Professional Attire Required. Men wear coat and tie/ladies wear dresses or dress pantsuits. No pagers, cell phones or pocketbooks allowed in the courtroom.
